

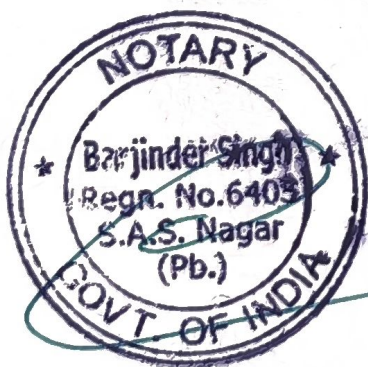

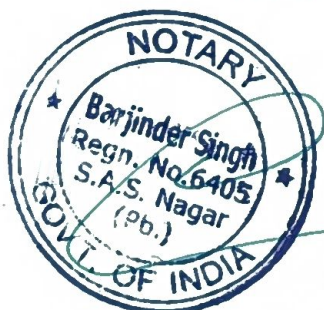

16. That the school will not sponsor students from other Board.

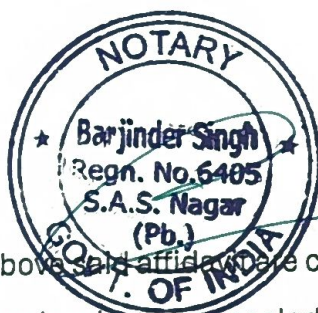
